Location is the Warren County Fairgrounds, Route 519, Harmony Twp.

Show hours are **10 a.m. - 4 p.m. both days**. Set-up is 2-8pm, Friday Aug 15; 6-10 a.m. Saturday, Aug 16; 8-10 a.m. Sunday, Aug 17.

TERMS TO WHICH EXHIBITOR AGREES:

1. To provide a professional display in the exhibiting area.
2. Setup must be complete before show opening.
3. ***NO PACKING BEFORE THE END OF THE SHOW. YOU MUST KEEP YOUR SPACE UP UNTIL 4 P.M.**
4. Contract and fee due immediately. Only a signed contract and payment will reserve your preferred space.
5. Tables must be covered to the floor and all packing material will be placed out of view. Show committee, management, owners of property, their agents, servants, and employees shall not be liable for injury to person or property during the show or during arrival or departure.
6. The Exhibitor will not sublet all or any part of his area.
7. If the premises are destroyed by fire or any other cause making it impossible to have the show, the lease shall terminate and the dealer shall waive claim for damages except return of deposit paid.
8. Cancellation policy: 50 percent refund available if you must cancel no less than 2 weeks before the show. Refunds for last minute cancellations are at the discretion of the organizers.
9. Exhibitor is responsible for his or her own insurance, bodily injury, property damage, and product coverage, and for sales tax. Although setup the night before the show is permitted for your convenience and the facilities will be locked for the night, the Warren County Antiques Show & Vintage Marketplace assumes no responsibility for the safety of your items.
