**EXHIBITOR CONTRACT**

**Set-up hours are 2-8 p.m., Friday, Aug. 18th; 6:30-10 a.m. Saturday, Aug. 19th; 8-10 a.m. Sunday, Aug. 20th.**

**TERMS TO WHICH EXHIBITOR AGREES:**

1. Exhibitor shall provide a professional display in the exhibiting area. No new items or reproductions are permitted.
2. Setup must be complete before show opening. **NO PACKING BEFORE THE END OF THE SHOW. YOU MUST KEEP YOUR SPACE UP UNTIL 4 P.M.**
3. Contract and fee due immediately. Only a signed contract and payment will reserve your preferred space.
4. Tables must be covered to the floor and all packing material will be out of view. Show committee, management, owners of property, their agents, servants, and employees are not liable for injury to person or property during the show or during arrival or departure.
5. If the premises are destroyed by fire, flood or any other cause making it impossible to have the show, the lease shall terminate and the dealer shall waive claim for damages except return of fee paid.
6. Cancellation policy: 100 percent refund available if you cancel by May 31st; 50 percent refund June 1-July 31.
7. Exhibitor is responsible for his or her own insurance, bodily injury, property damage, and product coverage, and for sales tax. Although setup the day before the show is permitted for your convenience and the facilities will be locked each night, the Warren County Antiques Show assumes no responsibility for the safety of your items.
8. Free admission for each dealer and one helper is included in this contract.
